

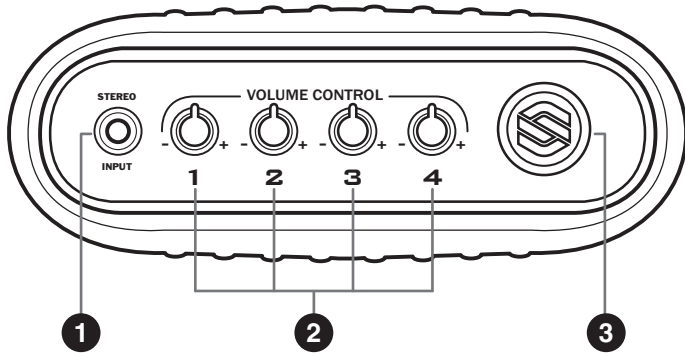

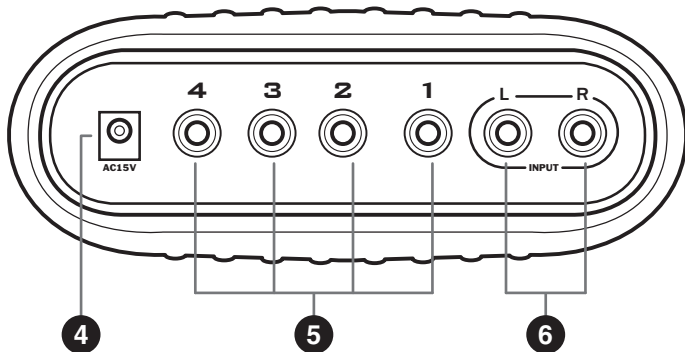
FRONT PANEL

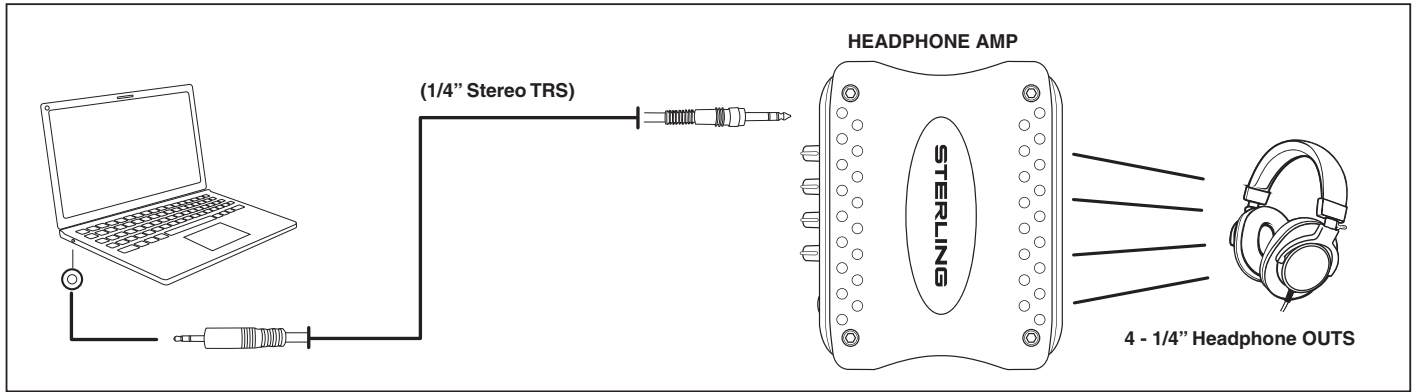

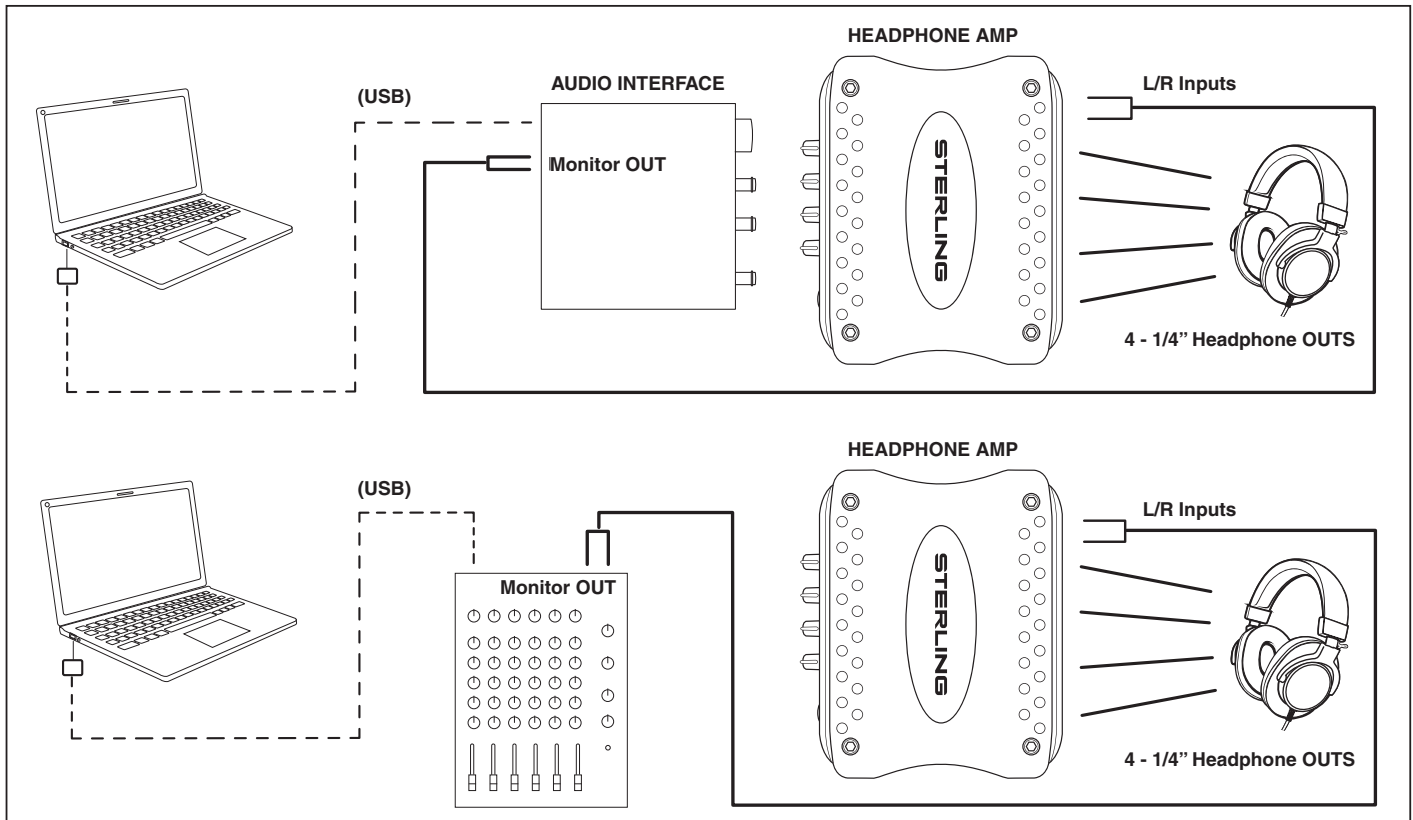
